During inspection, if Society/Trust is found not following declared standards, then Divisional Joint Director can act as given in sub-rule (1) of rule 11, and can suspend school's accreditation.
- If School is not found to follow conditions and responsibilities given under Rule 5 and 9 as well as instructions and guidance issued by Department from time to time, the undersigned will have the power to suspend the school's recognition on the basis of investigation
- 9. In case of any Explanation Call, if the reply received from Society/Trust is not found to be satisfactory, then after giving last hearing opportunity, the school's recognition can be canceled.
- o. Upon withdrawal of recognition, Security Fee deposited will be fully or partly, as specified in the order, will be seized.
- 1. It will be mandatory to get affiliation with the Central Board Secondary Education, and follow all norms as given in NOC Affiliation Bye-Laws
- 2. In case of any dispute, the jurisdiction of the Court shall be at Bhopal.
